**ZOOM ANNUAL MEETING**

August 15, 2020

President Gerfers called the meeting to order. There were 15 members and guests in attendance. The opening prayer was given by Art Gray.

**Minutes:** Copies of the minutes from the previous annual meeting were made available to the members. A motion was made by Gary Nagel to accept the minutes and seconded by Phil Dalmolin. The vote was unanimous.

**Financial Reports:** David Schneider, Treasurer, presented the financial report for 2019. Mr. Schneider presented a brief explanation of expenses and donations for 2019 and thanked everyone for their generosity. Copies of the financial report were made available to the members. A motion was made by Carl Ohlenbusch to accept the report as presented; it was seconded by Kathy Wynn and passed unanimously.

**Audit Committee:** Arthur Gray, Chairman, reported that The Audit Committee, consisting of himself, Phil Dalmolin and Tom DeKunder, reviewed the financial records for the period ending December 31, 2019. Mr. Gray presented his report and stated that the financial records are in order and they fairly state the financial position of the cemetery association.

**Coker Book Update:** “Haunting the Graveyard: Unearthing the Story of The Coker Settlement.”

President Gerfers presented a spreadsheet which revealed our budget, expenses and revenue for this book. Our book came in \$4,807.69 under budget. There has been a total of \$7,354.69 in sales, which represents 279 hardcover and 3 E-books. The books are currently on sale through September 15<sup>th</sup> for the price of \$28 with no shipping charges.

**SAWS Project:** Gary Nagel reported that SAWS has given the contractor the information regarding what we require for completion, including protection of the Heritage Oak Tree. SAWS stated that someone from Coker Cemetery Association now needs to meet with the contractor to be sure that we are like-minded with all details of this project.
