**ZOOM ANNUAL MEETING**

May 2, 2021

President Gerfers called the meeting to order at 2:05. There were 9 members and guests in attendance. The opening prayer was given by President Gerfers.

**Minutes:** Copies of the minutes from the last annual meeting were provided to the members via ZOOM app through a link provided. A motion was made by Carl Ohlenbusch to accept the minutes and second was made by David Schneider. The vote was unanimous.

**Financial Reports:** David Schneider, Treasurer, presented the financial report for the year 2020. Mr. Schneider presented a brief explanation of the expenses and donations for 2020 and mentioned that the generosity had been high this past year. Also, the PayPal method on the website as another stream for contributions has been working out well. Copies of the financial reports were made available to the members. Acknowledgement and opportunity for questions was made by President Gerfers for the report and he thanked Mr. Schneider for his efforts. No one had any questions about the report.

**Audit Committee:** Tom DeKunder, Chairman, reported that this committee consisting of himself, Phil Dalmolin and Arthur Gray had reviewed and accepted the financial records ending December 31, 2020. **Coker Book Update:** “Haunting the Graveyard: Unearthing the Story of The Coker Settlement.”

Since North Loop Road is currently not passable, all traffic to and from the cemetery currently has to pass from the Wurzbach Parkway through the church parking lot.
